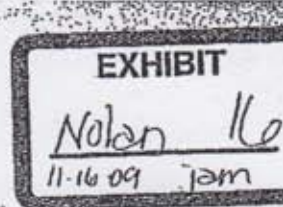

Bill O'Reilly on International Diplomacy:

"I just wish Katrina had only hit the United Nations building, nothing else, just had flooded them out. And I wouldn't have rescued them."

- Radio Factor, September 14, 2005

Bill O'Reilly on greater security at the Mexican/American border:

"We'd save lives because Mexican wetbacks, whatever you want to call them, the coyotes -- they're not going to do what they're doing now"

- In an interview with Congressman Silvestre Reyes on Feb. 6, 2003

Bill O'Reilly on the imaginary Peabody Award:

"I anchored a program called Inside Edition, which has won a Peabody Award for investigative reporting,"

- August 30, 1999.

"Well, all I've got to say to that is Inside Edition has won, I believe, two Peabody awards, the highest journalism award in the country,"

- The Factor - May 8, 2000.

A Timeline of the Sexual Harassment Lawsuit against Bill O'Reilly

Oct 13th, 2004 - O'Reilly files pre-emptive lawsuit against his accuser, calling her an extortionist.

Oct 13th, 2004 - Hours later - a Sexual Harassment lawsuit filed is against O'Reilly, Along with all the "he said/she said" stuff - the complaint contains paragraphs that clearly indicate there were witnesses, and that there was audio tape of some of the offending conduct.

Oct. 21st, 2004 - both sides agreed to a one-week postponement of legal proceedings

Oct 28th, 2004 - Bill O'Reilly and accuser settle. Awkward. Mr. O'Reilly is the married father of two.

3 weeks later - Accuser buys condo on Upper West Side of NY for \$809,500. Her previous salary at Fox News was \$93,000.

May 2006 - Accuser spends another \$430,950 on an adjacent unit in the building.

3. At all times mentioned herein, Defendant NEWS CORPORATION, was and is a corporation incorporated in Delaware with its principal place of business in New York. Defendant NEWS CORPORATION is one of the largest media corporations in the world.

two" and alluded to having a menage a trois with Plaintiff and her friend.

41. On or about May 2003, Defendant BILL O'REILLY took Plaintiff ANDREA MACKRIS and her college friend to dinner at Da Silvano's. During the course of the dinner O'REILLY repeatedly propositioned the women, singing the praises of telephone sex, offering telephone them both, and suggesting that the three of them "go to a hotel together and have time of [their] lives." O'REILLY further suggested that the women needed to be trained so they'd be equipped and ready to go when a "real man shows up in your lives," and offered "lessons." O'REILLY further suggested they use their sexuality to their advantage so they'd have power over men, otherwise men would have power over them. Plaintiff was extremely embarrassed and protested: "Bill, you're my boss!"

42. During the course of this dinner, in approximately May 2003, Defendant BILL O'REILLY, without solicitation or invite, regaled Plaintiff and her friend with stories concerning the loss of his virginity to a girl in a car at JFK, two "really wild" Scandinavian airline stewardesses he had gotten together with, and a "girl" at a sex show in Thailand who had shown him things in a backroom that "blew [his] mind." Defendant then stated he was going to meet the Pope, that his pregnant wife was staying at home with his daughter, and implied he was looking forward to some extra-marital dalliances with the "hot" Italian women. Both Plaintiff and her friend were repulsed, but felt powerless to protest strongly since Defendant was Plaintiff's boss and a powerful man at FOX. Defendant finally stopped after noting: "MACKRIS can't handle it."

43. On or about September 2003, Defendant BILL O'REILLY asked Plaintiff ANDREA MACKRIS to dinner at an Italian restaurant around the corner from FOX, purportedly to discuss business. During the course of dinner, Defendant once again raised d

would be work-related, and returned the call. Instead, Defendant BILL O'REILLY once again launched into a lewd and lascivious, unsolicited and disturbing sexually-graphic talk.

77. Despite informing him that she was not at all interested in the conversation, despite her adamant refusal to participate in such talk, Defendant O'REILLY informed Plaintiff ANDREA MACKRIS that he was watching a porn movie and babbled perversely regarding fantasies concerning Caribbean vacations because, purportedly: "Once people get into that weather they shed their inhibitions, you know they drink during the day, they lay there and they have dinner and then they come back and fool around... that's basically the modus operandi."

78. During the course of his monologue, Defendant O'REILLY further stated:

oops - looks like this is a videotape - from a tape!!!

Well, if I took you down there then I'd want to take a shower with you right away, that would be the first thing I'd do... yeah, we'd check into the room, and we would order up some room service and uh and you'd definitely get two wines into you as quickly as I could get into you I would get 'em into you... maybe intravenously, get those glasses of wine into you...

You would basically be in the shower and then I would come in and I'd join you and you would have your back to me and I would take that little loofa thing and kinda' soap up your back... tub it all over you, get you to relax, hot water... and um... you know, you'd feel the tension drain out of you and uh you still would be with your back to me then I would kinda' put my arm - it's one of those mitts, those loofa mitts you know, so I got my hands in it... and I would put it around front, kinda' rub your tummy a little bit with it, and then with my other hand I would start to massage your boobs, get your nipples really hard... 'cuz I like that and you have really spectacular boobs...

So anyway I'd be rubbing your big boobs and getting your nipples really hard, kinda' kissing your neck from behind... and then I would take the other hand with the salafel (sic) thing and I'd put it on your pussy but you'd have to do it really light, just kind of a tease business...
